The Parties agree that the Mediator shall not be liable to the Parties in contract, tort (including negligence and/or breach of statutory duty) or otherwise howsoever except for fraud or fraudulent misrepresentation.

7. LAW AND JURISDICTION

This agreement shall be governed by, construed and take effect in accordance with Irish Law. The courts of Ireland shall have exclusive jurisdiction to settle any claim, dispute, or matter of difference which may arise out of or in connection with the mediation.
